### COURSE CONTENT **CLASSES**

Discussion and students presentations of reading assignments on the problems concerning the role of the doctor and the doctor-patient relationship, hospital as a social institution based on students research, quality of life, chronic disease, disability and models of hospital care.

#### **LECTURES**

Lectures presents main concepts in sociology of health and medicine, history of the field and key analytical categories as social inequalities, medicalisation, cultural complexity of health and illness and more.

#### **EDUCATIONAL OBJECTIVE:**

The aim of the course is to acquaint students with problems that are raised by the sociology of health and medicine, through a critical analysis of the function of physician in the health care system. During the course will be presented the key areas of social analysis related to medicine, basic categories - health and disease - in a social context, medicalization, social exclusion and the role of social groups in the functioning of medicine. Participants will learn a variety of relationships between the state of health, causes of diseases, and cultural determinants of behavior in health and disease as well as the social interactions that take place on the basis of medical institutions and society. The course will outline the impact of culture, the process of socialization and the economy on the functioning of the health system and health behavior. The course participants will be able to critically use this knowledge in professional activity, understanding public attitudes towards certain diseases and excluded groups, social barriers conditioning adaptation to chronic illness, disability, old age. They will understand the existing mechanisms for different models of interaction between doctor and patient and their social roles.
